



2018 Youth Shotgun Clinic

Instructions and Information for Participants and Parents/Guardians

Clinic Dates: June 11~15, 2018

Program Objective:

The Youth Shotgun Clinic is offered by the Folsom Shooting Club (FSC), Inc., operators of the Sacramento Valley Shooting Center (SVSC) for the purpose of promoting firearm safety and introduction of shotgun sports, including trap, skeet, and other similar shooting games. Children participating in the clinic will gain an understanding of safe shotgun handling, the anatomy of a shotgun, introduction to shotgun sports, and a certificate for completing the NRA Basic Shotgun Course.

Program Acceptance:

Applicants will be selected on a first come first served basis. With the exception of first time applicants who will be given higher priority over applicants who have participated in prior SVSC shotgun clinics. Applicants returning from prior SVSC shotgun clinics may not participate in the NRA Basic Shotgun Course but may participate on days 3, 4 and 5. The NRA Basic Shotgun Course is limited to 20 participants. On days 3, 4, and 5, the maximum number of participants will be 25.

Fees:

All shotguns, ammunition, shooting pouches, and fees will be provided by the Folsom Shooting Club, Inc. Students must provide their own eye and ear protection appropriate for shooting firearms.

Parent Participation:

Parents must be present during all shooting activities as stated below. Parents should have medical coverage capability in possession.

Instructors:

The NRA Basic Shotgun Course will be provided by volunteers who are certified by the NRA as Shotgun Instructors. During shooting activities, various members of the Folsom Shotgun League will provide assistance for additional safety and coaching.

We have planned for an interesting, enjoyable and safe experience. The clinic is funded by the Folsom Shooting Club Inc. and all instructors and assistants are unpaid volunteers. Additional Program Information and Instructions:

1. All clinic activities will be conducted at the Sacramento Valley Shooting Center (SVSC), which is owned and operated by the Folsom Shooting Club, Inc. (FSC).
2. The clinic begins with the NRA Basic Shotgun Course on June 11 at **9:00 a.m.** in the SVSC **classroom** trailer. The trailer is visible to the right as you drive to the end of our club road on the way to the Main Range Office. The class will conclude at about 4:30 p.m.

The NRA course is a two day course that **must** be completed successfully in order to participate in the shooting activities later in the week. The first day of the NRA course includes only indoor classroom instruction following the NRA course design.

Recommendations and clarifications:

- Students should bring a lunch, snacks and drinks. There will be no time for lunch offsite.
- Students should bring a pen or pencil and note pad.
- Students must **NOT** bring any firearm or ammunition to the NRA course.
- Parents need not stay for the course on June 11. The classroom is not able to accommodate 20 students with parents.
- On June 12, the activity will be conducted under the awning behind the Shotgun Range Office beginning at 9:00 a.m. **Parents must be present for the afternoon shooting activity**. The shotgun range is the first facility visible as you enter the SVSC. Consider the need for a lunch, hat, sun-screen and water. Eye and ear protection are required for everyone at the range including parents/guardians. There are two restrooms at the Shotgun Range Office.

Absences and makeup: The NRA course on June 11 and 12 must be completed in order to participate in the shooting activities of June 13, 14 and 15.

- A student may not miss any portion of the NRA course.
- There is no makeup opportunity.
- There are no exceptions.
- If a student is not able to attend and complete the NRA course, the application to attend the clinic should be retracted in order that someone else may attend.

3. June 13, 14 and 15 2018. We will begin at 9:00 a.m. under the awning near Trap field #1 at the SVSC Shotgun range. The awning is easily visible from the Shotgun Range parking lot. On these dates students will learn trap and skeet shooting. Recommendations and clarifications:
 - On these dates activity should be concluded by 1:00PM.
 - Parents must be present and remain on site. There are shaded seating areas.
 - Consider the need for morning break food, hat, water and sun-screen.
 - Students and parents/guardians must have eye and ear protection.
 - Students may bring their own shotguns. However, the clinic is designed to use club shotguns. Please inform one of the instructors before bringing the shotgun from your vehicle.

4. Parents are required to sign-in each day of the Clinic at the site of the Clinic.

The Folsom Shooting Club, Inc., reserves the right to deny any person from participating in the clinic who is unable to participate fully without special needs or physical limitations, and expel any person from the clinic for unsafe firearm handling, unsafe or disruptive behavior.
